

Morris Knowles Hired by MECALL Services for New Sanitary Sewer Line Extension in East Franklin Township

East Franklin Township, Armstrong County, PA *received a \$1,771,562 principal forgiveness loan* to construct a new 7,000-foot sanitary sewer line extension along Toy, Booher, and Claypoole Roads. Once connected to the West Hills Area Water Pollution Control Authority system, the extension will lead to the decommissioning of the existing Fox Hollow Sewage Treatment plant, which has been experiencing hydraulic and organic overloading, and addressing effluent violations documented by the Department of Environmental Protection.

In 2023, MECALL Services was named the retained engineer for East Franklin Township, and brought on Morris Knowles as a subconsultant to assist with the funding and permitting for the project which involved a 7,000 L.F. gravity sanitary sewer system and decommissioning of an existing wastewater treatment facility for the Fox Hollow Estates Housing Development. Engineering Services Provided Include:

- Sewer easements, sewer rate analysis
- Funding administration with PennVest

Morris Knowles & Associates Assists Salem Township, PA for CCTV Inspection of Public Sanitary Sewer Lines

Salem Township was awarded \$366,666. grant through the Pennsylvania Commonwealth Finance Authority to perform CCTV inspection of their sanitary sewer lines. Salem Township's Sanitary Sewer Engineer, Morris Knowles & Associates has been instrumental in working with the Township to assist with funding for the project.

This project will provide for CCTV (Camera) inspections of approximately 15 miles of sanitary sewer lines within the Township's sanitary sewer system. These inspections are required and assess structural and performance issues within the system, locate laterals and clean the pipes of debris. A robotic camera will identify cracks and fractures, root intrusions and leaking water at joints.

Upon completion, Morris Knowles will:

- Review the inspections
- Prepare a corrective action plan to eliminate grade 4 and five defects within the sewer system, which is required per the consent order and agreement.

Josephine Waterline in the Village of Lakemore

Hammontree & Associates was hired by the Village of Lakemore to provide surveying and engineering services for the design to replace the existing 6" water main on Josephine Avenue between Sanitarium Road and Church Street. The project also included resurfacing the full width of Josephine Avenue.

Bridge News

Our bridge design team recently completed the final plans for the replacement of a culvert on Germantown Road (CR 250) in Noble county with a 5 foot by 5 foot box culvert on a realigned section of road, and a bridge on Hissom Road (TR 1206) in Monroe County with a 25 foot prestressed concrete box beam bridge with a composite concrete deck.

Our team is now entering the design phase for the replacement of two bridges in Harrison County, Blairmont Road (CR 13) over the north Fork of Short Creek and Elk Run Road (TR 340) over Brushy Fork. These Harrison County bridge designs will be completed in 2024. Portage County is also receiving attention from our engineers as we are the designers for the Jones Road design-build bridge replacement.
